

Question:

Last quarter's newsletter article covered who can sign an acknowledgement of the informed consent. That article said informed consent was a process. What is the process and what documentation should be in the ASC medical record to confirm the process occurred?

Answer:

You should consult with legal counsel if you have questions about your processes. The following is not legal advice. However, it may help you evaluate your practices and learn about areas on which you should seek advice from your medical malpractice carrier and/or legal counsel about how to handle the consent
